## DKK 50 MILLION TO A NEW ROUND OF THE AU IDEAS PROGRAMME

In 2013 the Aarhus University Research Foundation has allocated DKK 50 million to a new round of the AU IDEAS programme which supports freedom of research and good research ideas.

A more detailed call for AU IDEAS applications is expected to be published at the beginning of March 2013, with application deadline at the end of May 2013. The grant recipients will be announced in September/October 2013 with a view to project start in January 2014.

AU IDEAS is an initiative that was created through a collaboration between the Aarhus University Research Foundation and Aarhus University. The IDEAS programme, which distributed funding for the first time in December 2011, aims to help realise visionary and original project ideas.

## OUTLOOK CALENDAR - FREE OR BUSY

## HOW TO ADD HOLIDAYS TO YOUR OUTLOOK CALENDAR

By default, no holidays are loaded when you begin using the Outlook calendar, but Microsoft Outlook has a built-in feature to add holidays from different countries to your default calendar folder. You can add holidays to your Calendar folder by following these steps:

1. Make sure that your Outlook is set to Danish
  2. Click Files
  3. Choose Options
  4. Choose Calendar
  5. Click Add holidays
  6. Mark the countries whose holidays you would like to show in your Outlook calendar and press OK.

### STAFF PORTRAIT: CHRISTIANE GASSE

---



This time [Christiane Gasse](#) has agreed to answer the questions for the staff portrait. Thank you, Christiane. Christiane is Senior Researcher at the Department and is affiliated with [NCRR](#) - National Centre for Register-based Research.

**How long have you been employed at NCRR?**

I have been employed at the National Centre for Registry-based Research for 6 years.

**What is your background?**

I am a pharmacist with a PhD in medical sciences from the University of Muenster and a diploma in Epidemiology and Biostatistics from the McGill University, Montreal, Canada. Through my post doc position at Boston University I developed into a serious pharmacoepidemiologist investigating medical drug use and its side effects in the population. Pharmacoepidemiology has been a niche for some time as the discipline depends on large amounts of data to detect rare events. This was almost the main reason why I came to Denmark in 2005 (to work with register data) after some frustrating times at the university hospital in Heidelberg, Germany. Somehow I stayed. Beside in academia, drug safety is naturally also a general public health concern and also of quite some interest to pharmaceutical companies. Therefore collaborations between these three domains are common.

**What are your main areas of research?**

My main area of research is course and outcome of pharmacological treatment in psychiatric patients with schizophrenia or depression. I really like this area as psychiatry or mental health affect and include all aspects of life, and besides medical sciences, also other disciplines such as sociology and psychology contribute to investigate the reasons, risks and outcomes of these diseases. Though I would not perform research that did not involve drugs I am aware of the fact that drugs are not the solution to everything, or even anything?

**What research projects are you working on at the moment?**

I am currently mainly involved in two EU funded projects called CRESTAR and PROTECT. I am really glad for the funding as it allows me to work relatively independent from drug companies and will last almost until the end of 2015. Moreover I appreciate the international collaborations with experts in the respective fields.

In CRESTAR we try to find socio-demographic, clinical and genetic predictors for identifying patients with schizophrenia at an early stage who will be difficult to treat successfully with standard antipsychotic treatments. The earlier these patients could be safely offered a particular other and unique drug, namely clozapine, the better the long-term outcome of these patients may be.

In PROTECT we have the opportunity to compare and develop new methods in pharmacoepidemiology to quantify and communicate risks and benefits of pharmacological treatment in the population. Here we have chosen an example of antiepileptic drugs and the risk of suicide.

Other projects I am involved in concern antidepressive treatment response, sickness absence in users of antidepressants, pharmacological treatment of patients with dementia, and others.

**What are you involved in teaching-wise at the moment?**

I mainly teach on a one-to-one level, mainly my PhD student and a couple of other medical and PhD students in Aarhus and Copenhagen.

**Are you planning to take part in any conferences or the like abroad in the near future?**

As we have a number of interesting results coming up I have planned to participate with a group of collaborating researchers in the International Conference in Pharmacoepidemiology in Montreal this year. It is generally a very inspiring and refreshing conference with good net-working opportunities and a great place to meet friends in the field.

Additionally I would like to spend a month at the University of Chapel Hill to broaden my skills.

**Are you expecting any visiting researchers from abroad in the near future (or have you had any visitors from abroad recently)?**

As my main projects are international and it is only possible to work with Danish drug data in Denmark we have frequently visitors coming over from abroad.

**Are you cooperating with researchers from other departments at AU at the moment?**

Currently I am mainly collaborating with researchers from the faculty of Health. Due to several arrangements within our department I had the chance to meet a number of very nice colleagues and found that we may have common interests and supplementing skills, not only regarding pharmaco-economics or health economics. Everybody interested in working with prescription drug data having

some questions are more than welcome to contact me!

**What do you do when you are not at work?**

I am together with my boys cooking, traveling, singing and running around.
