This time [Orimar Sauri](#) has agreed to answer the questions for the staff portrait. Thank you, Orimar. Orimar is a PhD student at the Department and is affiliated with CREATES.

**How long have you been a PhD student at the Department of Economics and Business?**

I have been a PhD student for almost two years.

**What is your background?**

During my bachelor, I studied Mathematical Engineering (Applied Mathematics) at the Superior School of Physics and Mathematics (ESFM) at the IPN in Mexico City. Later, for my master, I studied Probability and Statistics at the Center for Research in Mathematics (CIMAT).

**What are your main areas of research?**

My main research interests lie in stochastic modelling of commodity prices, volatility of the underlying, and interest rates, including its calibration, with particular focus on the Ambit Stochastic framework. Also, I am interested in infinitely divisible distributions and stochastic analysis.

**What is in your experience the biggest difference between being a PhD student and being a regular student?**

How to get the problems! When you are a student you must solve the problems that the professors give to you, but being a PhD you must find interesting problems to solve (which is not trivial at all). That is for me the biggest difference.

**Are you teaching any classes this semester, or what are you going to teach next semester?**

Next semester I will be a teaching assistant for the course Mathematical Economics II.

**Are you planning to take part in any conferences or PhD courses in the near future?**

Not at the moment.

**Have you been abroad in connection with your PhD study (or where are you planning to go)?**

I will go to the Imperial College in London at the end of this year.

**What do you do when you are not at work?**

I love to listen to music, mainly Jamaican music from the 60's. I am always looking for new songs to listen to. Also, I like to go out and dance to almost any kind of music. When I am at home (and I have time) I like to cook - it just relaxes me. Unfortunately, I don't cook Mexican food so often because it takes a lot of time!
