WINTER SCHOOL 2017



During the past two weeks 60 students from different universities in Australia visited the Department in connection with the Winter School programme.

During the first week of their visit, the Australian students were lectured by Hans Martens from *Tænk tanken Europa* about EU matters and [Allan Sørensen](#) about the Danish economy. The second week Robson Silva Rocha from Department of Management lectured on Internationalisation, and special guest Senior Director Christoffer Østergaard Poulsen from Bang & Olufsen gave a talk about Bang & Olufsen and his experiences with cultural differences when doing business with other European countries.

Winter School ended on Friday 20 January with a 3-hour on-site exam, as well as a take-home assignment which must be handed in by March.

During their stay, the students also had time for a bit of sightseeing around Aarhus as they visited The Old Town and AROS, and they went for a guided

tour in the city and enjoyed a traditional Danish Christmas Lunch in Klubben. All in all a very interesting and successful visit from Down Under.

- **DFF Danish Council for Independent Research /Social Sciences:**

- **The DFF-International Postdoctoral Grant** is aimed at researchers at the start of their careers, i.e. within -6 months to +3 years of completing their PhD at the time of application. The funds are given for two-year post doc studies at an international host institution of which 6 months are spent at a Danish research institution.

- **The Sapere Aude DFF-Starting Grant** is aimed at researchers who are within 8 years of completing their PhD and who have demonstrated an ability to carry out research at a high international level. A max of DKK 4.1 million excluding overhead can be applied for.

- **International Research stays** of minimum 3 months duration may be applied for by post-PhD researchers and for an amount up to DKK 300,000, excluding overhead.

The overall objective is to strengthen international competitiveness and facilitate the development of world-leading Nordic research environments. Each university consortium may receive NOK 2-10 million in NordForsk funding per year for the period 2018-2020, and thereafter NOK 1-5 million per year through 2023. The participating universities, universities of applied sciences and university colleges must contribute resources equaling twice the amount of funding sought from NordForsk from 2018 through 2023.

- Jens Christian Skou Senior Fellowships: Fellowship duration from 6 to 12 months for researchers at a high international level, equivalent to professors or highly qualified associate professors with postdoctoral research careers of +10 years.
