## REMINDER REGARDING MARKING AT AARHUS BSS



With a new exam period approaching, here is a reminder of the BSS guidelines regarding marking at exams:

Co-examiners and examiners must mark numerically from -3 to 12 and B/I (Passed/Not Passed). The mark -3 should only be give if a student has submitted a written exam paper which in terms of academic content corresponds to the mark -3. An exam paper which has been uploaded to the wrong exam flow must also be marked -3.

As from the winter exams 2016-17, examiners must, on a few occasions, type administrative marks (in WISEflow, STADS-VIP or paper based grade reports).

# NEW PROCEDURES FOR HANDWRITTEN APPENDICES AT WISEFLOW EXAMS



Aarhus BSS Studies will implement new procedures for the submission of handwritten appendices at WISEflow on-site examinations:

#### FLOWlock exams (WO)

As of the 2017 summer exams, it is no longer possible to submit handwritten appendices at FLOWlock exams (WO). Instead, the students must either use the webcam on their computer to take photos of any handwritten appendices (e.g. drawings by hand, formulas) or use the built-in drawing tool in the programme to create freehand drawings.

Prior to the FLOWlock exams, detailed guidelines will be sent to the students via the exam flow in WISEflow and the guidelines will also be handed out in the exam room.

#### FLOWassign exams (WOAI and WOA)

At FLOWassign exams, the students can use all the digital tools on their own computer. As such, there is no need to submit handwritten appendices at these exams.

However, if the lecturer has a well-founded reason for allowing the students to submit handwritten appendices at a FLOWassign exam, this is still possible.

This must be indicated on the <u>exam information sheet</u> by ticking the box "Handwritten attachments allowed". The exam information sheet must be submitted to the BSS Studies Administration in the usual way and the reason for permitting handwritten appendices must be included in the email.

## ANONYMIZATION AT EXAMS



As from the summer exams 2017, the students will be anonymized at the written take-home assignments and the on-site exams without a subsequent oral exam. This means that flow-serial numbers will be used instead of student registration numbers at these exams.

Student registration numbers will still be used in connection with:

- written take-home assignments and on-site exams with a subsequent oral exam
- hand-written on-site exams (ON)
- exams that consist of several parts where one mark is given
- group assignments.

## STAFF PORTRAIT: CARSTEN BERTHRAM ANDERSEN



This time <u>Carsten Andersen</u> has agreed to answer the questions for the staff portrait. Thank you, Carsten. Carsten is a PhD student at the Department and is member of the Labour and Public Policy section.

How long have you been a PhD student at the Department of Economics and Business Economics?

Since August 2016, so nine months.

#### What is your background?

I have an MSc in Mathematics-Economics from Aarhus University, where I graduated in 2016.

#### What are your main areas of research?

Health Economics - e.g., the relative contributions of education and intelligence in mortality outcomes.

## What is in your experience the biggest difference between being a PhD student and being a regular student?

Monthly income and the amount of street credit from the outside world.

## Are you teaching any classes this semester, or what are you going to teach next semester?

I am currently a teaching assistant in Quantitative and Qualitative, Limited Dependent Variables (4th semester oecon). Next semester I will be lecturing a 10-hour brush-up course in econometrics, possibly grading some exam papers and then I will practically have finished the teaching obligations.

## Are you planning to take part in any conferences or PhD courses in the near future?

In a few weeks I am going to a research workshop on public policies, health and health behaviors, where I plan to bring a poster presenting some results/research ideas. I am possibly doing a DGPE course on spatial econometrics in June.

## Have you been abroad in connection with your PhD study (or where are you planning to go)?

I have not been abroad yet, and have not figured out where to go.

#### What do you do when you are not at work?

Play football (by which I naturally mean soccer), read books, being with friends. Currently going through 'Mad Men' at high pace with my girlfriend.

## Supplementary question from <u>Jorge Hansen</u>: How many (math) equations are there in your master thesis?

"There were three math equations in my master's thesis. Frankly, this shocked Jorge when I told him. And I think this is why he wants me to admit it in public. I guess that number is sort of a record in master's theses from the Department of Mathematics. However, the thesis turned out fine and as a wise man once said: 'The number of equations in a master's thesis is not a quality measure in itself."
