BIOPAC SEMINAR

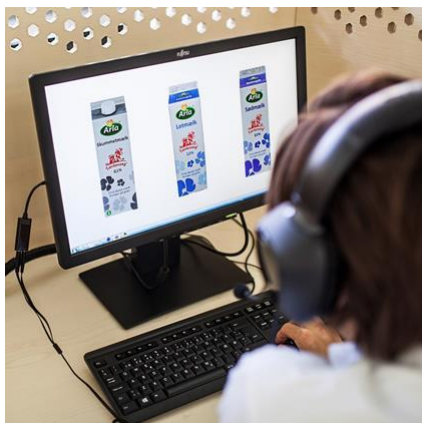

CAMPAIGN TO STOP ILLEGAL COPYING AND SHARING OF STUDENT BOOKS



Rettighedsalliancen is launching a campaign to guide students on how to avoid violating the rules regarding copying of books and sharing digital books. The campaign will reach all our students via the study portals and Blackboard during the coming weeks.

Illegal copying of books and illegal sharing of digital books are serious offences, but unfortunately many students are not aware of this and thus they risk breaking the law without knowing it.

A survey by Epinion from June 2019 showed that more than 50 % of the students who use digital books get them illegally.

As a lecturer, you are encouraged to spread the word of the campaign among your students.

BE PATIENT WHEN SWIPING YOUR ACCESS CARD THROUGH THE CARD READER!



Building Services at Campus Fuglesangs Allé get quite a few inquiries regarding faulty access cards. Many of these inquiries can be solved simply by a little patience and knowledge of how the system works, so here is a quick guide as to how to swipe your access card through the card reader:

1. Swipe your card through the reader
2. Three small coloured lamps on the reader will flash for approx. 3-6 seconds (- the system needs a little time to identify your card!)
3. Once the orange lamp lights up, you can dial your code
4. If the code is correct, the orange light will switch to green and the door can now be opened

If you use the same card reader frequently, you will only experience points 1, 3 and 4 when swiping your card through the card reader.

EVACUATION DRILL



An evacuation drill will be carried out at Fuglesangs Allé on **Tuesday 24 September at 13:00**.

The drill will include buildings 2622(C) and 2623(D).

Before the evacuation drill, please make sure to:

- study the general [AU evacuation procedure](#)
- study the content of the evacuation boxes
- remember the meeting points:
 - in front of the main entrance between buildings 2631(K) and 2632(L)
 - the parking area behind building 2636(U)

When the drill starts:

- close the window and lock the door to your office
- act as prescribed in the [evacuation procedure](#)

It is important that every employee knows the evacuation procedure – that is the main purpose of the drill.

Please react as if it is not a drill – this is the only way that we can learn from it.

A well-planned drill will last approximately 15-30 minutes from the evacuation signal is given and until everybody is back in their offices.

Also, remember to download the [AU Evacuate app](#). The app alerts you directly by means of an alarm sound on your smartphone in critical situations, and it keeps you updated on how the situation is developing and when it is over. The app will also alert you when there is an evacuation drill.

TOR ERIKSSON - 25-YEAR ANNIVERSARY



On 30 August 2019, Professor [Tor Eriksson](#) could celebrate his 25th anniversary as a state employee.

When asked about his thoughts regarding the anniversary, Tor replied that he was actually surprised when he discovered that it had been 25 years since he came to the business school in Aarhus - Things have changed a lot since 1994. He knew some colleagues doing labor economics here, and upon arrival he also joined CLS (Center for Labour Market and Social Research) funded by Grundforskningsfonden.

Back then the department was small (located in the current I-building) but dynamic, organically growing through more students and research funding. Hence, the department had to move first to Prismet and then to Frichshuset, and later to Fuglesangs Allé in connection with the merger with AU.

At ECON most of us probably know Tor as a member of the management team (head of the IOT section) - He admits, though, that to begin with he was not a great fan of admin duties. His first experience of a major admin task was when he was elected member of the cand.merc. study board (although he had been promised there was no risk that he would be). At the first meeting, the dean made him chairman because he was the only "senior enough" member. The good thing was that he got to know most of the faculty members at the other departments. Following this experience, Tor recommends that everybody should do some admin tasks for some period of their career since, on the margin, you might gain more from learning from and about your colleagues than from publishing still one more paper.

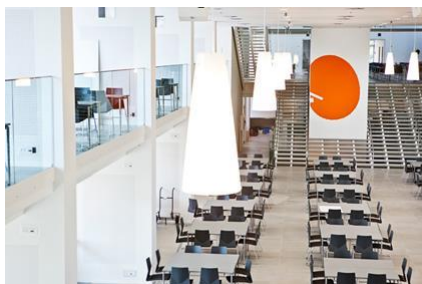
STEEN NIELSEN WINS EMERALD LITERATI AWARD

IRFD'S AUTUMN 2019 AND SPRING 2020



The Independent Research Fund Denmark (IRFD) has published its call for proposals of independent research funds for the autumn 2019/spring 2020-round – see the call via the link below.

The autumn deadline for applications to IRFD|Social Sciences is 4 October 2019 at 12:00 noon for the following instruments:

- DFF Research Project 1 (up to DKK 2,000,000 excluding overheads),
- DFF Research Project 2 (up to DKK 4,300,000 excluding overheads)
- International Research Stay (DKK 300,000 excluding overheads)

For the International Postdoctoral Grant, the deadlines are 5 November 2019 at 12:00 noon and 26 March 2020 at 12:00 noon. And for the Sapere Aude Starting Grant, the deadline is 26 March 2020 at 12:00 noon.

NORDFORSK CALL - INTERDISCIPLINARY RESEARCH PROJECTS



NordForsk has sent out a call for proposals for their new Nordic programme for interdisciplinary research, which has a budget of NOK 120 million.

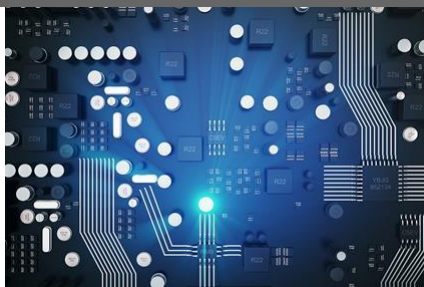
The call is specifically aimed at interdisciplinary projects that combine disciplines which rarely collaborate or that pursue an original research question requiring the exact combination of competencies from different disciplines. Projects awarded funding must include at least two of the following three areas: Life Science, Physical Sciences & Engineering, and Social Sciences and Humanities.

The maximum funding per project is NOK 15 million, and NordForsk hopes to fund 8 - 12 research projects under this call. Funding will be granted for up to four years, and successful proposals must include partners from at least three Nordic countries.

The deadline for submitting proposals is 13 November 2019.

THE VILLUM SYNERGY PROGRAMME



VILLUM FONDEN wishes to strengthen new collaborations that combine expertise within computer science with other research areas and thus calls for applications for its Villum Synergy Programme, for which an amount of DKK 50 million is allocated.

Project grants of DKK 2-3 million for up to two years are available for new collaborations. Established collaborations mature enough to benefit from a large grant can apply for a full project grant of DKK 10-20 million for three to five years.

Projects should involve two PIs that are both affiliated with a Danish research institution - One should be a methodological expert from computer science, statistics or applied mathematics and the other a domain expert from a field of application that may be broadly chosen, e.g. social science.

Deadline is 10 October 2019 at 14:00.

AUFF NOVA GRANTS



The Aarhus University Research Foundation (AUFF) calls for applications for the Nova 2019 funding programme.

The aim of AUFF Nova is to stimulate courageous and innovative research projects of high quality – projects which may have difficulties obtaining alternative funding. The project must be pioneering in its field and show clear potential for scientific breakthroughs. The hypothesis or problem behind the project may require development of new methods and it may challenge existing paradigms. If relevant, multi-disciplinary elements and synergies within the research team(s) should be clearly identified.

The programme includes two types of grants:

- Small projects (up to DKK 600,000) with a duration of 1-2 years
- Large projects (up to DKK 3 million) with a duration of 3-4 years

The deadline for applications is 4 October at 12 noon.

FUNDING FOR COMPETENCE DEVELOPMENT



From 4 September you can apply for funding for individual competence development from the Agency for Competence Development in the State Sector (Den Statslige Kompetencefond).

The criteria as regards the nature of the activities to be funded and the amounts to be awarded will vary depending on the collective agreement under which you are employed.

The fund was established as part of the collective agreement negotiations in 2018, and DKK 172 million has been earmarked for distribution among state sector employees until 2021.

VISITING ASSOCIATE PROFESSOR FOR THE NEXT 5 YEARS

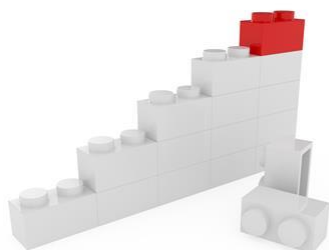
