[Jesper Wulff](#) and [Shin Kanaya](#) have both received AUFF Nova grants from the Aarhus University Research Foundation:

Associate Professor [Jesper Wulff](#) has received DKK 2 million for his project entitled "Opening the black box: Making Machine Learning Interpretable for Organizational Research". Associate Professor [Allan Würtz](#) is also part of this project.



Associate Professor [Shin Kanaya](#) has received DKK 360,000 for his project entitled "Estimating a meat demand system and prices of economic interventions to achieve environmental targets". Associate Professor [Marija Banovic](#) from MGMT is also part of the project.

The AUFF Nova aims to stimulate courageous and innovative research projects of high quality, which are pioneering in their fields and show clear potential for scientific breakthroughs.

### CALL: AIAS FELLOWSHIPS

---



[The Aarhus Institute of Advanced Studies \(AIAS\)](#) calls for applications for the following fellowships:

- **Jens Christian Skou fellowships**  
AIAS has up to four Jens Christian Skou fellowships available for talented junior and senior researchers from all academic disciplines.

AU employees with a distinguished track record in research, who intend to explore innovative, high-risk topics in their scientific research areas, are encouraged to apply.

Applicants must have a PhD and a minimum of two years of postdoctoral research experience, at the time of the application deadline. Furthermore, applicants must hold a tenured position or be in a tenure track position at AU at the time of the application deadline and at the time of commencement of the fellowship.

AIAS fellows are expected to be situated in AIAS' buildings on campus.

A fellowship has a duration of 6 to 12 months with commencement on 1 October 2020 or 1 February 2021.

- **AIAS-COFUND Marie Skłodowska-Curie fellowships**

AIAS has up to 15 AIAS-COFUND Marie Skłodowska-Curie fellowships available for talented junior and senior researchers from all academic disciplines who are seeking to enhance their understanding of methodologies and approaches of their own and other scientific disciplines and to explore these approaches, thus making cross-disciplinary inspiration and initiatives possible.

The programme encompasses two types of fellowships:

- AIAS-COFUND Junior Fellowships for postdoctoral researchers with a career experience of 2-10 years. Fellowship duration: 12-36 months.
- AIAS-COFUND Senior Fellowships for researchers with a career experience of 10+ years. Fellowship duration: 6-18 months.

Applicants must have a PhD and a minimum of two years of fulltime postdoctoral research experience at the time of the application deadline. Applicants must also comply with a mobility demand.

Commencement date: 1 October 2020 or 1 February 2021.

The application deadline is 17 January 2020.

Fulbright Denmark calls for applications for the following grants:

- **Fulbright Danish Visiting Scholar**

Postdocs, assistant professors, associate professors and professors who are planning a research and teaching stay in the US in 2020-2021 can apply for this grant of DKK 200,000. The stay must be for one or two semesters (4-10 months).

- **Fulbright Danish Student**

Master's and PhD students who are planning a research stay in the US in 2020-2021 can apply for this grant. You can apply for DKK 50,000 for one semester, or DKK 85,000 for the whole academic year.

Deadline for applications for both grants is 4 March 2020 at 12 noon. Applicants must be Danish citizens.
