

A report on the Danish manufacturing sector entitled "Danish Manufacturing – Winning in the Next Decade" prepared by <u>The Tubora Research Centre for</u> <u>Globalisation and Firms</u> and McKinsey & Company was presented at an event at the home of the Confederation of Danish Industries in Copenhagen earlier this month.

The report is the result of one of the most comprehensive surveys ever made of the Danish manufacturing sector, based on analyses of altogether 225 companies and input from 250 executives.

The following funding opportunities may be relevant to you:

FACE: Fund for Academic Cooperation and Exchange between Denmark and the Arab World

Established as a new Danish-Arab Partnership Programme (DAPP) engagement to support academic cooperation between Denmark and the MENA region.

Danish institutions that have entered into collaboration with partners from the MENA region can apply for funding for academic partnership projects.

FACE supports two types of grants:

- Large grants (between DKK 50,000 and 2,000,000 per year).
 Deadline is 30 March 2016.
- Small grants (up to DKK 50,000 DKKK) for e.g. academic exchange visits, organizing of conferences, seminars and meetings, etc.
 Deadline is 1 March 2017.

NORFACE: Dynamics of Inequality Across the Lifecourse: structures and processes (DIAL)

New Opportunities for Research Funding Agency Co-operation in Europe (NORFACE) is a collaborative partnership of national research funding agencies from 18 European countries in the area of social and behavioral sciences.

The DIAL call for proposals has four themes:

- 1. early life influences and outcomes
- early adult transitions into tertiary education, vocational training and economic activity
- 3. labour market and family trajectories and the growth of inequality
- 4. labour market participation in later life and retirement.

The deadline for phase one applications is 30 March 2016.

A project requires minimum 3 partners from the participating countries.

The budget limit is € 1,500,000 across all participating partners.

STAFF PORTRAIT

STAFF PORTRAIT: ALEXANDER PAUL



This time <u>Alexander Paul</u> has agreed to answer the questions for the staff portrait. Thank you, Alexander. Alexander is assistant professor at the Department.

How long have you been employed at the Department of Economics and Business Economics?

Since September 2015.

What is your background?

I obtained my PhD in Economics from the University of Mannheim, Germany, last summer. My bachelor's and master's degrees are from the same institution, but I also spent some time abroad, namely at Bocconi University in Milan and at the University of California in Berkeley, USA.

What are your main areas of research?

My research is centered in applied econometrics. So far, I have mainly worked on health economic questions, such as the impact of patient cost-sharing on health care utilization. Recently, I have become increasingly interested in the formation of skills and intergenerational inequality.

What research projects are you working on at the moment?

In one project with my former colleagues Gerard van den Berg and Steffen Reinhold, we investigate the effect of the business cycle on newborn health outcomes, in particular we ask whether recessions can actually be beneficial to babies.

I am also about to start two new projects with colleagues here in Aarhus. The first one aims at decomposing health care use in Denmark into factors attributable to demand (such as age and health of the patients) and factors attributable to the doctor (such as practice styles and available technology). It is joint with Anton Nilsson and Niels Skipper.

The second project together with Michael Rosholm will be concerned with the formation and persistence of skills during childhood and their interaction with parental characteristics.

What are you involved in teaching-wise at the moment?

In spring 2016 I am teaching the Descriptive Economics, part of the Business Economics course for HA-Bachelor students.

Are you planning to take part in any conferences or the like abroad in the near future?

Yes, I have submitted to a few conferences and I now hope for positive replies.

Are you expecting any visiting researchers from abroad in the near future (or have you had any visitors from abroad recently)?

Although I am not formally hosting him, I am happy that my co-author Anton Nilsson of Lund University is visiting the department and will be here for several months.

What do you do when you are not at work?

In an attempt to master the Danish language, I attend classes with Lærdansk twice a week - progress has been slow but steady so far.

To stay in good physical shape, I try (and usually manage to) go running twice a week.
