The senior management team asked several relevant and supplementary questions. All in all positive feedback was received at the end of the meeting so they may come back some other time to learn more...


### HEADS OF SECTIONS MEETING

### INTERNATIONAL POSTDOC SCHOLARSHIPS



In order to enhance the excellence of young researchers, the Danish Council for Independent Research offers postdoc scholarships of which a minimum of 18 months out of 24 are to be spent at a foreign university.

The aim of the scholarship is to help young researchers build up a strong international network to benefit from in their future career as researchers. The research stay can be spent at one or several foreign universities.
