The most important changes are in relation to the administration of the study programmes. FIN and FIB, and [Annia Hoffmeyer](#) will be taking over HA Statistics and Quantitative Methods and Cand.merc. Business Intelligence. Charlotte Sparrevohn will still be in charge of HA LOG/SMC and Cand.merc. LOG, and she will become more involved in the planning of conferences and workshops. The new member of the ECON Administration, [Anne Charlotte Dornonville de la Cour](#) will be in charge of the BSc oecon, math-econ and public policy programmes, including bachelor projects and master theses.

The changes will come into effect as from 1 December 2016, except the changes in relation to HR – they will become effective as from 1 January 2017.
